

**AAdvantage “40th Anniversary Celebration” Promotion
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. Eligibility: AAdvantage “40th Anniversary Celebration” Promotion (the “Promotion”) is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old as well as members of the American Airlines AAdvantage® program at the time of entry. Entrants who are not AAdvantage® members may join at no cost online at www.aa.com/loyalty/enrollment/enroll or by calling the AAdvantage® membership desk at 1-800-882-8880. AAdvantage® terms and conditions apply. Except as described in the following sentence, employees of American Airlines, Inc. (“Sponsor”), Merkle Inc. (“Administrator”), and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible (exceptions apply). *Employees of American Airlines, Inc. are only eligible to win Instant Win Game Prizes/Offers, as outlined in Section 8 below.* The Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited. For purposes of this Promotion, each “day” begins at 12:00:00 a.m. ET and ends at 11:59:59 p.m. ET. In addition, the Promotion consists of four (4) phases (each a “Phase”) as outlined below.

Administrator’s computer is the official time-keeping device for this Promotion.

4. How to Enter: During the Promotion Period, visit AAdvantage40th.com (“Website”) and follow the links and instructions to log into your AAdvantage member account (“Account”). On your successful log in to your Account, you automatically will receive one (1) entry into the Sweepstakes and advance to the Instant Win Game page and receive one (1) Instant Win Game play for that day. Once on the Instant Win Game page, follow the links and instructions to play the Instant Win Game. The Instant Win Game results will be instantly displayed. Potential winners of the Instant Win Game will be provided directions for validation. All potential winners are subject to verification before any prize/offer will be awarded. Administrator is responsible for the functionality of the Instant Win Game.

If you play the Instant Win Game and receive a “lose” message, as outlined above, meaning you are not a potential winner of an Instant Win Game Prize/offer, you will receive one (1) additional entry into the Sweepstakes.
